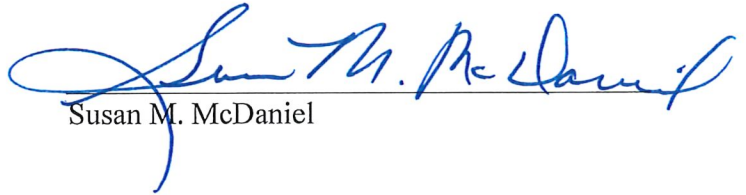

 - Your "hand" is now raised. If you change your mind and do not wish to speak, click the same button, now labeled "Lower Hand."

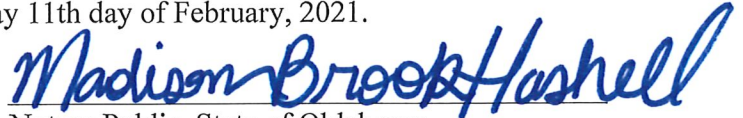
